


There have been recent changes to the NYS DOS Corporate Registration, the US GSA's System for Award Management (SAM) and the NYS Dept. of Labor sites.






➤ What's the difference between these two forms?



I'm finding the 6-month requirement when online questionnaires are completed, but can't find confirmation of this on the OSC website for paper questionnaires.

➤ Are there different term requirements for paper VRQs as opposed to online certifications, or is it 6 months across the board?

Will name changes made by the vendor in the Vendor Master File automatically update the information on the online VRQ (VendRep System)?



Can OSC make information available to the vendor population informing them that a certified VRQ does not mean the questionnaire has been reviewed and/or approved by the State contracting entity?



Is there a functionality within the online VendRep System that sends an automatic reminder to vendors when it's time to certify/re-certify their online VRQ?



➤ Does OSC have a document repository for paper VRQs?

➤ If yes, can any State agency access it to view the vendor's VRQ for the next 12 months?





We have many exempt vendors (mostly counties) that subcontract with private or non-profit vendors.

➤ What are the VR documentation requirements for these transactions and would a profile for the subcontractor be needed?



Does a non-registered business in NYS need a certificate of good standing from where they are incorporated?



Can a State agency contract with a vendor who was previously found non-responsible by another agency?



Understanding that each agency must make its own independent determination, if a previous agency finds a vendor non-responsible and during the same month, another agency is considering the same vendor, what level of independent investigation and determination is required by that second agency?
