 According to IRS Publication 5 (Circular E) and the instructions for Form W-2 (Wage and Tax Statement), employers are required to furnish each employee with a Form W-2 by January 31 of the following year.

Basic Information (cont.)

- Employees who work for more than one agency in the same company will receive *ONE* Form W-2
 - State of New York (NYS) *or* City University of New York (CUNY)
- Employees who work for more than one agency in multiple companies will receive a Form W-2 for each company
 - State of New York (NYS) *and* City University of New York (CUNY)

Basic Information (cont.)

- Starting with the 2020 Form W-2s, the IRS allowed employers to mask the first 5 digits of the employee's Social Security number on their printed W-2s.
- Reprinted W-2s, either through New York State Payroll Online(NYSPO) or by agencies, as well as W-2s on the *View W-2s* page in PayServ, will have the employee's full Social Security number.

Basic Information (cont.)

• The agency address will be used as the return address on the Form W-2 Statements.

• For employees that did not opt out of receiving a paper form W-2, OSC will mail the W-2 to the employee's mailing address listed in PayServ. If no mailing address exists, then the form will be mailed to the employee's home address.

- Bulletin 1890 informs agencies of the content information for 2020 For W-2.
- Attachment A lists all the boxes on the Form W-2 and their descriptions.
- Attachment B shows what deductions are taken before calculating an employee's taxable gross for Federal and Social Security and Medicare.

- Took effect 04/01/2021
 - Different than NYS policy that permitted no charge to accruals for vaccines obtained as of 03/12/2021.
- Extends the tax credit to eligible employers through 09/30/2021 for leave taken by employees as of 04/01/2021 to obtain the Covid-19 vaccine.

American Rescue Plan Act of 2021

- <u>Bulletin No. 1943</u> issued in September included a template for agencies to populate with the required vaccination information.
- Reflected on employee W-2s in Box 14 under paid sick leave or family medical leave.
