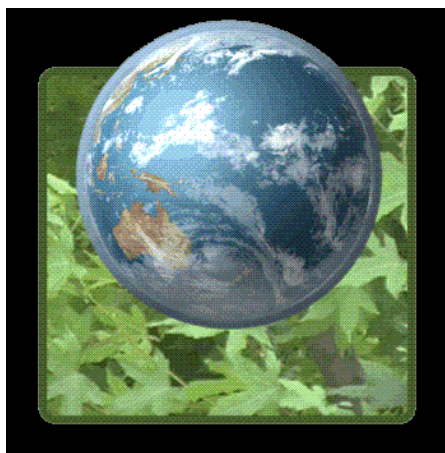

ABOUT THE COMPTROLLER'S OFFICE

As the center of government fiscal accountability in New York State, the Office of the State Comptroller audits government operations and issues reports on State finances.

In its audits of State agencies, local governments and school districts, the Comptroller's Office makes sure these entities comply with State laws, such as using cleaning products that do not harm people or the environment, as well as a host of other issues.

As sole trustee of the New York State Common Retirement Fund, Comptroller DiNapoli invests pension fund dollars in companies whose products solve environmental problems while earning attractive returns for the pension fund.

The Comptroller also administers the New York Environmental Protection and Oil Spill Compensation Fund, which settles damage claims resulting from oil spills.

ABOUT COMPTROLLER DiNAPOLI



Comptroller DiNapoli has been a strong advocate for New York's environment during his more than two decades in public service. As a former Assemblyman from Long Island, he championed a number of legislative initiatives, including the Pine Barrens Protection Act, the ban on the gasoline additive MTBE, the establishment of the Brownfields Cleanup Program, the enactment of the Pesticide Neighbor Notification Act and numerous other measures to improve the quality of the State's drinking water.

As the former chair of the New York State Assembly Committee on Environmental Conservation, DiNapoli brings an unprecedented level of environmental expertise to the Comptroller's Office. This first-of-its-kind environmental webcast is the product of his dedicated effort to bring awareness of environmental issues to the people of New York State.

On September 13, 2007, Comptroller DiNapoli signed an Executive Order on Energy and the Environment (available at www.osc.state.ny.us/press/releases/sept07/091307.htm) to make the New York State Office of the State Comptroller a model of sustainability.

Marcia Bystryn joined the New York League of Conservation Voters as Executive Director in June 1999. Prior to this, she served as the Senior Business Manager for Economic Development and Senior Corporate Policy Manager for the Environment at The Port Authority of New York and New Jersey, where she focused on the revitalization of the port and the many interwoven environmental issues. She also served as the Assistant Commissioner for Recycling at New York City's Department of Sanitation, where she integrated a comprehensive recycling program as part of the City's solid waste management policy, and was Deputy Director of the Twentieth Century Fund, now the Century Foundation.

While he has been DEC Commissioner for only one year, Pete Grannis' environmental leadership spans decades. As a State Assembly Member from Manhattan's Upper East Side, Mr. Grannis was well known for his proactive and forward-thinking environmental vision. From fighting to clean up long-festered toxic waste sites and reduce damaging acid rain to championing groundbreaking laws to increase recycling and protect residents from dangerous secondhand cigarette smoke, his thirty-two year tenure in Albany was marked by significant environmental victories. Commissioner Grannis' impressive legislative accomplishments have been recognized by numerous environmental, health and consumer organizations. In addition, Commissioner Grannis serves as Chairman of the Regional Greenhouse Gas Initiative.

Prior to joining Environmental Advocates of New York in 2004, Rob Moore served as the Lake Champlain Lakekeeper for the Conservation Law Foundation's Vermont Advocacy Center. Before that, he led Prairie Rivers Network in Illinois. Under his leadership, Prairie Rivers Network rose to prominence as one of the country's most respected statewide river conservation groups. For these efforts, Mr. Moore was recognized by the Natural Resources Defense Council and the Clean Water Network as one of "30 Clean Water Heroes of the Past 30 Years." He is a nationally recognized expert on the federal Clean Water Act and its application to local and statewide pollution problems. Mr. Moore has a Master's degree in Atmospheric Sciences from the University of Illinois and a Bachelor's degree in Physics from Illinois State University.

Professor Nicholas A. Robinson

Nicholas A. Robinson founded Pace's program in environmental legal education in 1978. From 1972 to 1992, he served on the U.S. Delegation to the environmental law negotiations with the USSR. He served as Legal Advisor and Chair of the Commission on Environmental Law for the International Union for the Conservation of Nature and Natural Resources from 1996 to 2004, and currently serves on the Environmental Advisory Council to the European Bank for Reconstruction and Development. He led the development of environmental law teaching in 15 Asian nations for the Asian Development Bank and founded the world's first consortium of law schools with environmental law programs. From 1983 to 1985, Professor Robinson served as General Counsel to the New York State Department of Environmental Conservation. Under Governor Carey, he organized and chaired the New York State Freshwater Wetlands Appeals Board and chaired the Environmental Advisory Board to Governor Mario Cuomo. Professor Robinson also chaired and incorporated the State's Greenway Heritage Conservancy for the Hudson River Valley.

Peggy Shepard is Executive Director and co-founder of West Harlem Environmental Action, Inc. Founded in 1988, WE ACT was New York's first environmental justice organization created to improve environmental health and quality of life in communities of color. A recipient of the 10th Annual Heinz Award for the Environment, Ms. Shepard is a former Democratic District Leader, who represented West Harlem from 1985 to 1993, and served as President of the National Women's Political Caucus – Manhattan from 1993 to 1997. From 2001 to 2003, Ms. Shepard served as the first female chair of the National Environmental Justice Advisory Council (NEJAC) to the U.S. Environmental Protection Agency and is co-chair of the Northeast Environmental Justice Network.
