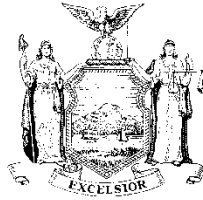

Dear Ms. Zimmerman:

This Amendment #1 modifies Contract C001119, Agreement for Professional Auditing Services for the State's Financial Statements and EMEDNY, between the Office of the State Comptroller, by the Department of Audit and Control ("OSC"), and KPMG, LLP (the "Auditor" or "Contractor") as follows:

1. The parties hereby agree to delete paragraph XI. AUDITOR INDEPENDENCE AND PROFESSIONAL STANDARDS, A. sub paragraph iii) and replace it with the following:

iii) The Auditor shall not audit its own work in any of its engagements with OSC.

The Auditor shall not assign any personnel to the engagement team providing services pursuant to this Agreement who are assigned or have been assigned to provide services pursuant to any other audit or services contract between KPMG, LLP and any bureau or division of the New York State Office of the State Comptroller, including but not limited to the New York State and Local Retirement System ("NYSLRS"), except as may expressly be agreed to in a writing executed by KPMG, LLP, OSC's Executive Deputy Comptroller for Operations (as relates to Contract C001119), and the Executive Deputy Comptroller or equivalent individual with signing authority for the bureau(s) or division(s) with which such resources will be shared. Such authorizations may be provided in separate writings by the affected OSC bureaus or divisions.

OSC's written approval of staff assignments for Contract C001119 shall not constitute approval for the use of any of the same staff to provide services under another contract entered into by any bureau or division of the Office of the State Comptroller (i.e., overlap staff), without the express written approval of an authorized representative of such bureau or division.

2. All other terms and provisions of Contract C001119, as previously amended, which are not inconsistent with the terms and provisions of this Amendment #1, shall remain in full force and effect.

3. The personnel listed on page 42 of KPMG's Technical Proposal are approved to provide services under Contract C001119. OSC further agrees that the following named KPMG personnel, acting as Subject Matter Professionals only, may provide audit services pursuant to Contract C001119, even if these individuals are also assigned to or are providing audit or audit-related services to NYSLRS:

- Adam Bender, TA Director
- Jeffrey Markert, GACB Technical Resource
- Carlos Gil Canizares, IT Manager
- Raymond Lucas, IT Senior Associate
- Justin Slater, IT Manager
- Alexander Smith, Consulting Actuary - OPEB

If KPMG seeks to have the foregoing individuals serve as overlap staff for any other KPMG engagement with the State, other than NYSLRS, KPMG must separately obtain the written permission and approval of the subject, potentially affected division or bureau and of OSC.

If KPMG proposes to overlap any other personnel assigned to C001119, KPMG must obtain OSC's prior written approval to do so.

4. As provided in Contract C001119, any change in designation of any persons responsible for the performance of services pursuant to Contract C001119 is subject to OSC's approval.
